Human FK506 Binding Protein 12 Rapamycin Associated Protein, FRAP GENLISA™ ELISA

Introduction:

The GENLISA[™] ELISA kits are used for assessing the specific biomarker in samples analytes which may be serum, plasma and cell culture supernatant as validated with the kit. The kit employs a sandwich ELISA technique which leads to a higher specificity and increased sensitivity compared to conventional competitive ELISA kits which employ only one antibody. Double antibodies are used in this kit.

Intended Use:

The Human FK506 Binding Protein 12 Rapamycin Associated Protein, FRAP GENLISA[™] ELISA kit is used as an analytical tool for quantitative determination of Human FK506 Binding Protein 12 Rapamycin Associated Protein, FRAP in serum, plasma and cell culture supernatant.

Principle:

The method employs sandwich ELISA technique. Monoclonal antibodies are pre-coated onto microwells. Samples and standards are pipetted into microwells and Human FK506 Binding Protein 12 Rapamycin Associated Protein, FRAP present in the sample are bound by the antibodies. Biotin labeled antibody is added and followed by Streptavidin-HRP is pipetted and incubated to form a complex. After washing microwells in order to remove any non-specific binding, the substrate solution (TMB) is added to microwells and color develops proportionally to the amount of Human FK506 Binding Protein 12 Rapamycin Associated Protein, FRAP in the sample. Color development is then stopped by addition of stop solution. Absorbance is measured at 450 nm.

Materials Provided:

- 1. FRAP Antibody Coated Microtiter Plate (12 x 8 wells) 1 no
- 2. Concentrated Standard, Human FRAP (80 ng/ml) 0.5 ml
- 3. Biotinylated FRAP Antibody 1 ml
- 4. Streptavidin-HRP Conjugate 6 ml
- 5. Standard Diluent 3 ml
- 6. 25X Wash Buffer 20 ml
- 7. Substrate A 6 ml
- 8. Substrate B 6 ml
- 9. Stop Solution 6 ml

Materials to be provided by the End-User:

- 1. Microtiter Plate Reader able to measure absorbance at 450 nm.
- 2. Adjustable pipettes and multichannel pipettor to measure volumes ranging from 25µl to 1000µl
- 3. Deionized (DI) water
- 4. Wash bottle or automated microplate washer
- 5. Graph paper or software for data analysis
- 6. Timer
- 7. Absorbent Paper

Handling/Storage:

- 1. All reagents should be stored at 2°C to 8°C for stability.
- 2. All the reagents and wash solutions should be used within 12 months from manufacturing date.
- 3. Before using, bring all components to room temperature (18-25°C). Upon assay completion ensure all components of the kit are returned to appropriate storage conditions.
- 4. The Substrate is light-sensitive and should be protected from direct sunlight or UV sources.

Sample Preparation and Storage:

Specimens should be clear and non-hemolyzed. Samples should be run at a number of dilutions to ensure accurate quantitation.

- 1. Extract as soon as possible after specimen collection as per relevant procedure. The samples should be tested as soon as possible after the extraction. Alternately the extracted samples can be kept in -20°C. Avoid repeated freeze-thaw cycles.
- 2. **Serum-** Coagulate at room temperature for 10-20 minutes; centrifuge for 20-min at 2000-3000 rpm. Remove the supernatant. If precipitation appears, recentrifuge.
- 3. **Plasma-** Use EDTA or citrate plasma as an anticoagulant, mix for 10-20 minutes; centrifuge for 15-min at 2000-3000 rpm. Remove the supernatant carefully. If precipitation appears, recentrifuge.
- 4. **Urine-** Collect urine in a sterile container, centrifuge for 20-min at 2000-3000 rpm. Remove the supernatant. If precipitation appears, recentrifuge.
- 5. Cell Culture Supernatant- Collect sample in a sterile container. Centrifuge for 20-mins at 2000-3000 rpm. Remove the supernatant carefully. When examining the components within the cell, dilute cell suspension with PBS (pH 7.2-7.4), if cell concentration is greater than 1 million/ml. Damage the cells by repeated freeze-thaw cycles to release intracellular components. Centrifuge for 20-min at 2000-3000 rpm. If precipitation appears, centrifuge again.
- 6. **Tissue Samples-** Rinse tissues in PBS (pH 7.4) to remove excess blood thoroughly and weigh before homogenization. Mince tissues and homogenize them in PBS (pH7.4) with a glass homogenizer on ice. Thaw at 2-8°C or freeze at -20°C. Centrifuge at 2000-3000 RPM for approximately 20 minutes and collect the supernatant carefully.

Note: Grossly hemolyzed samples are not suitable for use in this assay.

Reagent Preparation (all reagents should be diluted immediately prior to use):

- 1. Label any aliquots made with the kit Lot No and Expiration date and store it at appropriate conditions mentioned.
- 2. Bring all reagents to Room temperature before use.
- 3. To make Wash Buffer (1X); dilute 20 ml of 25X Wash Buffer in 480 ml of DI water.
- 4. **Standards Preparation**: Dilute 120 µl of original **Standard (80 ng/ml)** with 120 ul of standard diluent to generate a **40 ng/ml Standard stock solution**. Keep the standard for 15 mins with gentle agitation before making further dilutions. Prepare the **Standards** by serially diluting the standard stock solution as per the below table.

Procedural Notes:

- 1. In order to achieve good assay reproducibility and sensitivity, proper washing of the plates to remove excess un-reacted reagents is essential.
- 2. High Dose Hook Effect may be observed in samples with very high concentrations of Human FK506 Binding Protein 12 Rapamycin Associated Protein, FRAP. High Dose Hook Effect is due to excess of antibody for very high concentrations of Human FK506 Binding Protein 12 Rapamycin Associated Protein, FRAP present in the sample. High Dose Hook effect is most likely encountered from samples early in the purification process. If Hook Effect is possible, the samples to be assayed should be diluted with a compatible diluent.
- 3. Human FK506 Binding Protein 12 Rapamycin Associated Protein, FRAP concentration of the undiluted sample is less than the diluted sample, this may be indicative of the Hook Effect.
- 4. Avoid assay of Samples containing sodium azide (NaN₃), as it could destroy the HRP activity resulting in under-estimation of the amount of Human FK506 Binding Protein 12 Rapamycin Associated Protein, FRAP.
- 5. It is recommended that all Standards and Samples be assayed in duplicates.
- 6. Maintain a repetitive timing sequence from well to well for all the steps to ensure that the incubation timings are same for each well.
- 7. If the Substrate has a distinct blue color prior to use it may have been contaminated and use of such substrate can lead to compromisation of the sensitivity of the assay.
- 8. The plates should be read within 30 minutes after adding the Stop Solution.
- 9. Make a work list in order to identify the location of Standards and Samples.

Assay Procedure:

- 1. It is strongly recommended that all Standards and Samples be run in duplicates or triplicates. A standard curve is required for each assay.
- 2. Add **50 ul Standard** to standard well. *Note: Do not add* **Biotinylated FRAP Antibody** *to standard well because the Standard Solution contains the biotinylated antibody.*
- 3. Add 40 ul Sample to respective sample wells.
- 4. Pipette 10 ul Biotinylated FRAP Antibody to respective sample wells.
- 5. Pipette 50 ul Streptavidin-HRP Conjugate to respective sample wells and also the standard wells. *Note: Do not add the Strepatividin-HRP Conjugate to the blank well.*
- 6. Mix well. Cover the plate with a sealer and incubate for 60 minutes at 37°C.
- 7. Aspirate and wash plate 4 times with diluted **Wash Buffer (1X)** and blot residual buffer by firmly tapping plate upside down on absorbent paper. Wipe of any liquid from the bottom outside of the microtiter wells as any residue can interfere in the reading step.
- 8. Pipette 50 ul Substrate A followed by 50 ul Substrate B in all the wells.
- 9. Incubate the plate at at 37°C for 10 minutes. DO NOT SHAKE or else it may result in higher backgrounds and worse precision. Positive wells should turn bluish in color.
- 10. Pipette 50 ul of Stop Solution in all wells. The wells should turn from blue to yellow in color.
- 11. Read the absorbance at 450 nm with a microplate within 10-15 minutes after addition of Stop solution.

Calculation of Results:

Determine the Mean Absorbance for each set of duplicate or triplicate Standards and Samples. Using Graph Paper, plot the average value (absorbance 450nm) of each standard on the Y-axis versus the corresponding concentration of the standards on the X-axis. Draw the best fit curve through the standard points. To determine the unknown Human FK506 Binding Protein 12 Rapamycin Associated Protein, FRAP concentrations, find the unknown's Mean Absorbance value on the Y-axis and draw a horizontal line to the standard curve. At the point of intersection, draw a vertical line to the X-axis and read the Human FK506 Binding Protein 12 Rapamycin Associated Protein, FRAP concentrations, find the unknown's Mean Absorbance value on the Y-axis and read the Human FK506 Binding Protein 12 Rapamycin Associated Protein, FRAP concentration.

If samples were diluted, multiply by the appropriate dilution factor. Software which is able to generate a cubic spline curve-fit is best recommended for automated results.

Note:

It is recommended to repeat the assay at a different dilution factor in the following cases:

- If the sample absorbance value is below the first standard.

Quality Control:

It is recommended that for each laboratory assay appropriate quality control samples in each run to be used to ensure that all reagents and procedures are correct.

Standard Calibrator Provided:

Concentration - 80 ng/ml

Standard Calibration Range:

2.5 ng/ml – 40 ng/ml

Limit Of Detection:

It is defined as the lowest detectable concentration corresponding to a signal of Mean of '0' standard plus 2* SD. 10 replicates of '0' standards were evaluated and the LOD was found to be less than 2.4 ng/ml.

Safety Precautions:

- This kit is For Research Use only. Follow the working instructions carefully.
- The expiration dates stated on the kit are to be observed. The same relates to the stability stated for reagents
- Do not use or mix reagents from different lots.
- Do not use reagents from other manufacturers.
- Avoid time shift during pipetting of reagents.
- All reagents should be kept in the original shipping container.
- Some of the reagents contain small amount of sodium azide (< 0.1 % w/w) as preservative. They must not be swallowed or allowed to come into contact with skin or mucosa.
- Source materials maybe derived from human body fluids or organs used in the preparation of this kit were
 tested and found negative for HBsAg and HIV as well as for HCV antibodies. However, no known test
