Introduction:

The GENLISA™ ELISA kits are used for assessing the specific biomarker in samples analytes which may be serum, plasma and cell culture supernatant as validated with the kit. The kit employs a sandwich ELISA

technique which leads to a higher specificity and increased sensitivity compared to conventional competitive ELISA kits which employ only one antibody. Double antibodies are used in this kit.

Intended Use:

The Human Gap junction Beta-6 Protein, GJB6 GENLISA[™] ELISA kit is used as an analytical tool for quantitative determination of Human Gap junction Beta-6 Protein, GJB6 in serum, plasma and other biological samples.

Principle:

The method employs sandwich ELISA technique. Monoclonal antibodies are pre-coated onto microwells. Samples and standards are pipetted into microwells and Human Gap junction Beta-6 Protein, GJB6 present in the sample are bound by the antibodies. Biotin labeled antibody is added and followed by Streptavidin-HRP is pipetted and incubated to form a complex. After washing microwells in order to remove any non-specific binding, the substrate solution (TMB) is added to microwells and color develops proportionally to the amount of Human Gap junction Beta-6 Protein, GJB6 in the sample. Color development is then stopped by addition of stop solution. Absorbance is measured at 450 nm.

Materials Provided:

- Anti-Human Gap junction Beta-6 Protein, GJB6 Antibody Coated Microtiter Plate (8 x 12 wells) 1 no
- Human Gap junction Beta-6 Protein, GJB6 Standard (lyophilized, concentrated, for actual concentration please refer vial label) 2 vials
- Biotinylated Human Gap junction Beta-6 Protein, GJB6 Antibody (concentrated) 120 ul
- Streptavidin:HRP Conjugate (concentrated) 120 ul
- Sample Diluent 20 ml
- Biotin Antibody Dilution Buffer 10 ml
- HRP Conjugate Dilution Buffer 10 ml
- (25X) Wash Buffer 30 ml
- TMB Substrate 10 ml
- Stop Solution 10 ml
- Instruction Manual

Materials to be provided by the End-User:

- Microtiter Plate Reader able to measure absorbance at 450 nm.
- Adjustable pipettes and multichannel pipettor to measure volumes ranging from 25 ul to 1000 ul
- Deionized (DI) water
- Wash bottle or automated microplate washer
- Clean tubes and Eppendorf tubes
- Precision single and multi-channel pipette and disposable tips.
- 37°C incubator
- Timer.

Handling/Storage:

- All reagents should be stored as indicated on the component label.
- All the reagents and wash solutions should be used within 12 months from manufacturing date.
- Before using, bring all components to room temperature (18-25°C). Upon assay completion ensure all components of the kit are returned to appropriate storage conditions.
- The Substrate is light-sensitive and should be protected from direct sunlight or UV sources.

Sample Preparation and Storage:

Specimens should be clear and non-hemolyzed. Samples should be run at a number of dilutions to ensure accurate quantitation.

- Extract as soon as possible after specimen collection as per relevant procedure. The samples should be tested as soon as possible after the extraction. Alternately the extracted samples can be kept in -20°C. Avoid repeated freeze-thaw cycles.
- **Serum-** Coagulate at room temperature for 10-20 minutes; centrifuge for 20-min at 2000-3000 rpm. Remove the supernatant. If precipitation appears, recentrifuge.
- **Plasma-** Use EDTA or citrate plasma as an anticoagulant, mix for 10-20 minutes; centrifuge for 15-min at 2000-3000 rpm. Remove the supernatant carefully. If precipitation appears, recentrifuge.
- **Urine-** Collect urine in a sterile container, centrifuge for 20-min at 2000-3000 rpm. Remove the supernatant. If precipitation appears, recentrifuge.
- Cell Culture Supernatant- Collect sample in a sterile container. Centrifuge for 20-mins at 2000-3000 rpm. Remove the supernatant carefully. When examining the components within the cell, dilute cell suspension with PBS (pH 7.2-7.4), if cell concentration is greater than 1 million/ml. Damage the cells by repeated freezethaw cycles to release intracellular components. Centrifuge for 20-min at 2000-3000 rpm. If precipitation appears, centrifuge again.
- **Tissue Samples-** Rinse tissues in PBS (pH 7.4) to remove excess blood thoroughly and weigh before homogenization. Mince tissues and homogenize them in PBS (pH7.4) with a glass homogenizer on ice. Thaw at 2-8°C or freeze at -20°C. Centrifuge at 2000-3000 RPM for approximately 20 minutes and collect the supernatant carefully.

Note: Grossly hemolyzed samples are not suitable for use in this assay.

Sample Dilution

The user should estimate the concentration of target protein in the test sample, and select a proper dilution factor to make the diluted target protein concentration fall in the optimal detection range of the kit. Dilute the sample with the provided dilution buffer, and several trials may be necessary. The test sample must be well mixed with the dilution buffer. And also standard curves and sample should be making in pre-experiment. If samples contain very high concentrations of the analyte, dilute the samples with PBS first and then do further dilutions of the samples with the provided Sample Diluent in the kit.

Reagent Preparation (all reagents should be diluted immediately prior to use):

- Label any aliquots made with the kit Lot No and Expiration date and store it at appropriate conditions mentioned.
- Bring all reagents to Room temperature before use.
- To make Wash Buffer (1X); dilute 30 ml of (25X) Wash Buffer in 720 ml of DI water.
- Biotinylated Human Gap junction Beta-6 Protein, GJB6 Antibody Working Solution: Prepare it within 1 hour before experiment. Calculate required total volume of the working solution: 0.1 ml / well x quantity of wells. (Allow 0.1-0.2 ml more than the total volume. Dilute the Biotinylated Human Gap junction Beta-6 Protein, GJB6 Antibody (concentrated) with Biotin Antibody Dilution Buffer at 1:100 and mix them thoroughly (i.e. Add 1 ul Biotinylated Human Gap junction Beta-6 Protein, GJB6 Antibody into 99 ul Biotin Antibody Dilution Buffer).
- Streptavidin:HRP Conjugate Working Solution: Prepare it within 30 minutes before experiment. Calculate required total volume of the working solution: 0.1ml / well x quantity of wells. (Allow 0.1-0.2 ml more than the total volume. Dilute the Streptavidin:HRP Conjugate with Streptavidin:HRP Conjugate Dilution Buffer at 1:100 and mix them thoroughly (i.e. Add 1 ul of Streptavidin:HRP Conjugate into 99 ul of Streptavidin:HRP Conjugate Dilution Buffer).
- **Standards Preparation**: Reconstitute original Human Gap junction Beta-6 Protein, GJB6 Standard with 1 ml of Sample Diluent. Keep the standard for 15 mins with gentle agitation before making further dilutions. Prepare the additional Standards by serially diluting the standard stock solution as per the below table.

Note: actual concentration for the 1:1 dilution is to be determined as per the concentration indicvated on the standard vial label provided with the kit

Procedural Notes:

- In order to achieve good assay reproducibility and sensitivity, proper washing of the plates to remove excess un-reacted reagents is essential.
- High Dose Hook Effect may be observed in samples with very high concentrations of Human Gap junction Beta-6 Protein, GJB6. High Dose Hook Effect is due to excess of antibody for very high concentrations of Human Gap junction Beta-6 Protein, GJB6 present in the sample.
- Human Gap junction Beta-6 Protein, GJB6 concentration of the undiluted sample is less than the diluted sample, this may be indicative of the Hook Effect.
- Avoid assay of Samples containing sodium azide (NaN₃), as it could destroy the HRP activity resulting in under-estimation of the amount of Human Gap junction Beta-6 Protein, GJB6.
- It is recommended that all Standards and Samples be assayed in duplicates or triplicates.
- Maintain a repetitive timing sequence from well to well for all the steps to ensure that the incubation timings are same for each well.
- If the Substrate has a distinct blue color prior to use it may have been contaminated and use of such substrate can lead to compromisation of the sensitivity of the assay.
- The plates should be read within 30 minutes after adding the Stop Solution.
- Make a work list in order to identify the location of Standards and Samples.

Assay Procedure:

- It is strongly recommended that all Standards and Samples be run in duplicates or triplicates. A standard curve is required for each assay.
- Add 100 ul prepared Standards and diluted Samples to respective wells.
- Cover the plate with a sealer and incubate for 90 minutes at 37°C.
- Aspirate and wash plate 4 times with diluted Wash Buffer (1X) and blot residual buffer by firmly tapping plate upside down on absorbent paper. Wipe of any liquid from the bottom outside of the microtiter wells as any residue can interfere in the reading step.
- Pipette 100 ul Biotinylated Human Gap junction Beta-6 Protein, GJB6 Antibody Working Solution to all wells.
- Cover the plate with a sealer and incubate for 60 minutes at 37°C.
- Aspirate and wash as per Step (4) above.
- Pipette 100 ul Streptavidin: HRP Conjugate Working Solution to all wells. Mix well.
- Cover the plate with a sealer and incubate for 30 minutes at 37°C.

- Aspirate and wash as per Step (4) above.
- Pipette 90 ul TMB Substrate in all the wells.
- Incubate the plate at **37°C** for **10 minutes**. DO NOT SHAKE or else it may result in higher backgrounds and worse precision. Positive wells should turn bluish in color.
- Pipette 50 ul of Stop Solution to all wells. The wells should turn from blue to yellow in color.
- Read the absorbance at 450 nm with a microplate within 10-15 minutes after addition of Stop solution.

Calculation of Results:

Determine the Mean Absorbance for each set of duplicate or triplicate Standards and Samples. Using Graph Paper, plot the average value (absorbance 450nm) of each standard on the Y-axis versus the corresponding concentration of the standards on the X-axis. Draw the best fit curve through the standard points. To determine the unknown Human Gap junction Beta-6 Protein, GJB6 concentrations, find the unknown's Mean Absorbance value on the Y-axis and draw a horizontal line to the standard curve. At the point of intersection, draw a vertical line to the X-axis and read the Human Gap junction Beta-6 Protein, GJB6.

If samples were diluted, multiply by the appropriate dilution factor. Software which is able to generate a cubic spline curve-fit is best recommended for automated results.

Note:

It is recommended to repeat the assay at a different dilution factor in the following cases:

- If the sample absorbance value is below the first standard.

Quality Control:

It is recommended that for each laboratory assay appropriate quality control samples in each run to be used to ensure that all reagents and procedures are correct.

Performance Characteristics of the Kit:

This kit has been validated. Please view the details herein below.

Specificity:

This assay has high sensitivity and excellent specificity for detection of Human Gap junction Beta-6 Protein, GJB6. No significant cross-reactivity or interference between Human Gap junction Beta-6 Protein, GJB6 and analogues was observed.

Recovery

Matrices listed below were spiked with certain level of Human Gap junction Beta-6 Protein, GJB6 and the recovery rates were calculated by comparing the measured value to the expected amount of Human Gap junction Beta-6 Protein, GJB6 in samples.

Linearity

The linearity of the kit was assayed by testing samples spiked with appropriate concentration of Human Gap junction Beta-6 Protein, GJB6 and their serial dilutions. The results were demonstrated by percentage of calculated concentration to the expectation.
